Saint Anthony School Kailua **2024-2025** Tuition

St. Anthony School utilizes FACTS Tuition Management to collect all tuition and applicable fees. Families are required to establish a contract with FACTS regardless of the payment plan selected. FACTS charges a minimal one-time enrollment fee based on the payment plan selected. FACTS accounts can be set up through the school's website. Returning families will be rolled over to the new school year, once your Tuition Agreement is received.

Annual Payment Plan Discount: A \$200 discount will be applied to the above for full payment by Friday, July 5, 2024. Semi-annual or monthly payment plans will be debited through FACTS beginning in July 2024. If enrolling after, the payment will be collected upon registration.

Multiple-Child Discount: Tuition discount for multiple-child enrollment - \$250.00 per child (not including the first child).

Monthly Payment Plan: The monthly payment plan is collected through the FACTS program. You may select your payment date through FACTS for either the 5th or 20th of each month. Payments that begin in July 2024 will end in May 2025 for a total of eleven payments. All tuition is due in full to St. Anthony School by May 20, 2025. Payment plans that start after July will result in higher monthly payments. Please contact Sharon Davis at (808) 285-5611 with any questions.

Non-Refundable Registration Fee - \$350.00 per child. This amount is in addition to the tuition listed above and is required to secure the student's spot on the roster. This fee must be submitted with the Tuition Agreement Contract.

Non-Refundable Tuition Refund Policy (TRP) - \$225 per child. This amount is in addition to the tuition listed above and is optional for those who choose to pay in full through the annual payment. Payment is collected with the Tuition Contract Agreement.

What is the Tuition Refund Policy (TRP)?

Saint Anthony School depends on collecting the full tuition from all students for its operations. The obligation to pay the full tuition and fees for the entire academic year is unconditional, and no portion of such tuition or fees so paid or outstanding will be refunded or canceled notwithstanding the absence, withdrawal, or dismissal from St. Anthony School of the child during the academic year.

The Dewar Tuition Refund Policy (TRP) is tuition insurance that provides the school and/or parent with partial tuition coverage in the event a student does not complete the school year due to an absence, withdrawal, or dismissal. Families electing to pay tuition through the monthly or semi-annual payment schedules are required to purchase the Dewar Tuition Refund Policy (TRP). The non-refundable fee of \$225 is due at the time of enrollment. Families who elect to pay the tuition with a one-time payment are not required to purchase TRP, however, without it a refund **will not** be issued.

The Tuition Refund Policy becomes effective on August 1st in the event of the student's inability to attend school due to a covered medical reason. The non-medical coverage (voluntary withdrawals and dismissals) does not become effective until the student has attended fourteen consecutive calendar days (including weekends) commencing with the student's first class day of attendance in the academic year.

This ruling is necessary as the School has continuing expenses. (See the TRP brochure for more information).

Please read the Tuition Agreement Contract carefully for additional information. The Tuition Agreement Contract must be submitted with the Non-Refundable Comprehensive Fee, and TRP if applicable.

Other Fees That May Apply

- **Before School Care (BSC)** - \$50/month. Before School Care is available from 6:30 am – 7:30 am. BSC is a “drop-in” service (as needed) and the hourly charge of \$7.50 is based on usage. Monthly charges will be collected through FACTS Management.
- **After School Care (ASC)** - Like tuition, monthly payments will be collected through FACTS Management. Availability in ASC is on a first come first serve basis.
 - o ELC ASC hours are from Dismissal – 5:30 pm. The monthly rate is \$150. Snacks are provided. The hourly rate is \$7.50 per hour. Late pick-up fees apply at \$15.00 per fifteen minutes after closing.
 - o Grades K – 8 ASC hours are from Dismissal Time to 6:00 pm. Snacks are provided. The monthly rate is \$175.00. The hourly rate is \$7.50 per hour.
- **Malama Family Fee** –The Malama Family Fee is a mandatory fee of \$200.00 per year or 20 hours of service. Parents are given two choices; pay the fee on their FACTS account or volunteer and provide up to 20 hours of approved and recorded service for school projects. Families must keep track of their hours and have a faculty or PTSG board member verify the event. The form must be submitted to the school by April 15th to be credited to your account. Your accounts will be credited \$10 per hour for up to 20 hours. Failure to submit the form will result in a billing of \$200.
- **Sports Participation Fee**- \$25.00 for one sport and \$40.00 per two or more sports. (Grades 4th – 8th) charged through FACTS. Students must have a sports physical, and a signed parental permission slip waiver to participate in the Catholic School League and Christian Schools League.
- **Lunch Account** – Hot lunch (which includes a drink) is sold by the month at a rate of \$3.75 per day for Grades PS – 2, and \$ 4.00 per day for Grades 3 – 8. Also, milk and juice can be purchased separately. Monthly menus will be provided. Payments will be made through FACTS.
- **Field Trip** – Cost will vary depending on the activity. The school covers the cost of most field trips. However, notices will be sent home if any additional fee is to be collected.
- **Uniforms** are sold through **Dennis Uniforms Company**, located on Nimitz Hwy in Honolulu.
